# INTERNATIONAL PART TIME MBA

POLITECNICO DI MILANO SCHOOL OF MANAGEMENT



Contributions amounting to 25% of the tuition fee will be granted to two International Part-Time MBA students who are admitted to the program in the 2020 intake.

#### 1. BENEFICIARIES AND REQUIREMENTS

To be a recipient of one of the contributions outlined below, students must be successful in their application to the International Part-Time MBA program.

- CleanTech Challenge dedicated to the topic of Energy. The student awarded this contribution will become the assistant of the Italian Chapter of the CleanTech Challenge. Candidates wishing to apply for this opportunity need to write an essay (500-700 words) on the following topic: "Discuss the relevance of sustainability and renewable energies in today's world".
- Plastic-free Commitment (which is the new Global Commitment of the Ellen MacArthur Foundation). The student awarded this contribution will become the assistant of the Italian Chapter of the CleanTech Challenge and will support this special track dedicated to the promotion of a plastic-free world. Candidates wishing to apply for this opportunity need to write an essay on the following topic (500-700 words): "The New Plastics Economy Global Commitment draws a line in the sand, with businesses, governments and others around the world uniting behind a clear vision for what we need to create a circular economy for plastic. - Ellen MacArthur" - Discuss.

## 2. SUBMISSION OF AND DEADLINE FOR APPLICATION

A **Financial Aid Request Form** (provided upon request) must be completed and uploaded together with a copy of the candidate's **latest pay slip** to their application profile.

The CTC contribution will be awarded based on merit. However, early applications are encouraged as the contributions are assigned on a rolling basis.

## 3. EVALUATION AND OUTCOME OF APPLICATION

The CTC contribution will be awarded based on merit and candidates will be evaluated according to the following criteria:

- > academic and professional record
- > results of the International Part-Time MBA selection process
- > assessment of their written essay

The successful candidates will be notified formally by the Committee via their admissions email and contract. The awards are made at the sole discretion of the Committee, whose decision is final and cannot be appealed against.

### 4. INCOMPATIBILITY AND LOSS OF SCHOLARSHIP

This contribution can be combined with other scholarships, awards and/or financial support for specialisation courses offered by public or private bodies and/or companies, as long as the total amount does not exceed the total amount of the tuition fees. The beneficiary must self-certify that this total sum has not been exceeded. The beneficiary must comply with this condition for the whole duration of the International Part-Time MBA program.

#### 5. ACCEPTANCE OF THE CONDITIONS

Candidates applying for the CTC contribution must confirm their full acceptance of the related conditions, of which they will be notified in writing in the letter of assignment of the contribution.
