SIMONA ALBERTI
MEMORIAL
SCHOLARSHIP

Awarded by BSH Italy, this scholarship worth €3.000 is offered to one outstanding 2022/2023 Master in Environmental Sustainability & Circular Economy candidate.

The scholarship is named after Simona Alberti who was a BSH Italy employee very active in the environmental sustainability field. Candidates are chosen by a BSH Italy selection Committee.

1. BENEFICIARIES AND REQUIREMENTS

In order to apply for this scholarship, candidates are asked to present the following documentation:

- > Application Form;
- > Admission to the 2022 Master in Environmental Sustainability & Circular Economy Programme;
- > A product (the candidate can freely decide to share a text, photos, audio, video or even a mix) about a real and concrete example of Circular Economy he or she had the opportunity to get personally in touch with.

2. SUBMISSION OF AND DEADLINE FOR APPLICATION

Participants must send their application by e-mail to infomasters@mip.polimi.it, with subject line "CIRCULAR ECONOMY SCHOLARSHIP ALBERTI 2022/23", by no later than **31st May, 2022**. Only completed applications delivered by the due date will be submitted to BSH Italy.

3. EVALUATION AND OUTCOME OF APPLICATION

Candidates will be evaluated according to the following criteria:

- > Assessment of the product shared by the candidate
- > Academic and professional record
- > Results of the Master in Environmental Sustainability & Circular Economy selection process

The successful candidate will be notified formally by MIP Admissions Office by letter no later than 30th June, 2022. The scholarship is awarded at the sole discretion of the BSH Italy Committee, whose decision is final and cannot be appealed against.

Several unsuccessful applicants may be placed on a waiting list and be reconsidered, at the discretion of the Committee, if the candidate who was awarded the scholarship withdraws his or her application.

The scholarship will be officially presented to the winner during a commemorative event that will be held in early October 2022.

4. INCOMPATIBILITY AND LOSS OF SCHOLARSHIP

This scholarship can be combined with other scholarships, awards and/or financial support for specialisation courses offered by public or private bodies and/or companies, as long as the total amount does not exceed the total amount of the tuition fees. The beneficiary must self-certify that this total sum has not been exceeded. The beneficiary must comply with this condition for the whole duration of the Master in Environmental Sustainability & Circular Economy program.

In order to retain their rights to the scholarship, beneficiaries of a financial grant awarded on the basis of merit will be expected to maintain good academic performance throughout the Master in Environmental Sustainability & Circular Economy program, according to minimum standards set by the School.

The right to the scholarship is subject to the participant duly completing their 2022/23 Master in Environmental Sustainability & Circular Economy program.

5. PROJECT ACTIVITIES

The recipient of the scholarship could be asked to develop and carry on the project during the programme in agreement with BSH Italy.

6. ACCEPTANCE OF THE CONDITIONS

By applying to this scholarship and accepting the ensuing award, candidates fully agree to the conditions contained herein. Under penalty of the immediate withdrawal of their scholarship, the successful candidate must confirm that they are enrolled on the Master in Environmental Sustainability & Circular Economy programme for 2022/23, as well as formally accepting all scholarship conditions by informing the Admissions Office within the deadline indicated in the letter confirming that he/she has been awarded the scholarship.
