SCHOLARSHIP

Awarded by the Gianluca Spina Association, this scholarship worth 50% (gross) of the tuition fee is offered to one outstanding 2022/2023 iMSCPM candidate. The scholarship is named after Gianluca Spina who was the Dean of MIP Graduate School of Business and Full Professor in Business Management and Supply Chain Management at the Department of Management, Economics and Industrial Engineering of Politecnico di Milano. Candidates are chosen by a University-wide selection Committee.

### 1. BENEFICIARIES AND REQUIREMENTS

In order to apply for this scholarship, candidates with an outstanding personal, academic and professional background are asked to present the following documentation:

- > Application and admission to the 2022/2023 iMSCPM programme;
- > A 2,000 word essay on the following topic: *"Supply Chain and Procurement Management for Global and Sustainable Development"*.
- > A motivational letter in English addressed to the Gianluca Spina Association to support your candidature.
- > A valid GMAT/GRE score and an English certificate will be considered as an added value to your application, still they are not mandatory.

### 2. SUBMISSION OF AND DEADLINE FOR APPLICATION

Participants must send their application by e-mail to [infomasters@mip.polimi.it](mailto:infomasters@mip.polimi.it), with subject line "iMSCPM SCHOLARSHIP SPINA 2022/2023", by no later than **31<sup>st</sup> May, 2022**. Only completed applications delivered by the due date will be submitted to the Committee.

### 3. EVALUATION AND OUTCOME OF APPLICATION

Candidates will be evaluated according to the following criteria:

- > Academic and professional record
- > Results of the iMSCPM selection process
- > Assessment of their written essay
- > Letter of motivation addressed to the Association

The successful candidate will be notified formally by the Committee by letter no later than 30<sup>th</sup> June, 2022. The scholarship is awarded at the sole discretion of the Committee, whose decision is final and cannot be appealed against.

Several unsuccessful applicants may be placed on a waiting list and be reconsidered, at the discretion of the Committee, if the candidate who was awarded the scholarship withdraws his or her application.

### 4. INCOMPATIBILITY AND LOSS OF SCHOLARSHIP

This scholarship can be combined with other scholarships, awards and/or financial support for specialisation courses offered by public or private bodies and/or companies, as long as the total amount does not exceed the total amount of the tuition fees.

The beneficiary must self-certify that this total sum has not been exceeded.

The beneficiary must comply with this condition for the whole duration of the iMSCPM program.

In order to retain their rights to the scholarship, beneficiaries of a financial grant awarded on the basis of merit will be expected to maintain good academic performance throughout the iMSCPM program, according to minimum standards set by the School. The right to the scholarship is subject to the participant duly completing their 2022/23 iMSCPM program.

**5. PROJECT ACTIVITIES**

The recipient of the scholarship is expected to carry out a project assigned by the Director of the iMSCPM Programme, in agreement with the iMSCPM Faculty.

**6. ACCEPTANCE OF THE CONDITIONS**

By applying to this scholarship and accepting the ensuing award, candidates fully agree to the conditions contained herein.

Under penalty of the immediate withdrawal of their scholarship, the successful candidate must confirm that they are enrolled on the iMSCPM programme for 2022/23, as well as formally accepting all scholarship conditions by informing the Admissions Office within the deadline indicated in the letter confirming that he/she has been awarded the scholarship.
