# HOW TO OBTAIN THE FISCAL CODE (CODICE FISCALE)

**Last Updated September 2021** 



#### **OBTAINING YOUR CODICE FISCALE IN MILAN (Italian Tax Code)**

Your *Codice Fiscale* is issued, free of charge, by the taxation office (*Agenzia delle Entrate*). There are several offices in Milan, the main one located at Via della Moscova, 2.

Due to the Covid-19 pandemic, and in the effort to minimize people interaction, the fiscal code can now be requested via e-mail and issued as digital copy.

#### **Required documents**

- Filled out form
- Passport or European i.d. for EU students
- Passport for Non-EU students
- Italian visa for Non-EU students

As you fill out the form, write your personal data as they are in your passport. Your surname and name should be complete as written in your passport. In case you do not have a surname in your passport, you can fill the field with XXX.

#### How to request it

Fill out the application form as per the template below, and sign it. Sometimes due to a technical issue, the editable form cannot be fully read by the taxation office operator, therefore we suggest you scan it or save it as an uneditable pdf/image.

Scan all the required documents and send copy of them via e-mail to the taxation office competent for your area of domicile.

There are nine "zone" (areas of domicile) within the municipality of Milan. To find out which one you are domiciled in, please visit the Comune di Milano's <u>Geoportale</u>. You will see a map of the city divided in the nine areas. Click on the small button on the left (called "Trovalndirizzo" if you hover over it) and type in your address. Once you know your area, consult the list below to find out which office you need to write to.

### IMPORTANT NOTE – If you obtained your Fiscal Code from the Italian Consulate or if you change your Italian domicile after receiving your Fiscal Code

If you received your Fiscal from the Consulate, it means you did not give the Taxation Office an Italian domicile. Once you settle in Italy, we suggest you communicate your new long-term domicile to the Taxation Office via e-mail. To do this, the procedure is the same as above. Write an e-mail and attach copy of your passport (and visa or permit, if Non-EU) and the filled-out application form with your new Italian address. In the form, select "2. Change of details" in Section II, and write your fiscal code beside it.

Likewise, when you move to a new, longer-term domicile within Italy, it is advisable to update the Taxation Office on the same. Write to the office competent for the area of your new domicile.

Information regarding the processing of personal

#### the data contained in this form will be used and what rights are granted to citizens. data pursuant to Article 13 of Legislative Decree No 196 of 2003 Purposes of The Ministry of the Economy and Finance and the Revenue Agency inform you, on their behalf and on behalf of other persons obliged to do so, that in this form there is personal data that will be processed by the Ministry of the processing Economy and Finance and the Revenue Agency to allocate the tax code, obtain changes to personal and address details, obtain information on deceased persons, and send the tax code card or a duplicate of the national health system card. The data in the possession of the Ministry of the Economy and Finance and the Revenue Agency may be communicated to other public entities (for example, the Municipalities) where legislation provides for this, or when such communication is necessary in order for them to carry out their institutional functions. The same data may also be communicated to private or public economic entities where the legislation provides for this. Personal data The data requested in this form must be supplied to prevent the application of administrative and, in some cases, criminal sanctions. Method of The paper form must be submitted by the person concerned, or through a delegate, to any Revenue Agency office. processing Any person(s) resident overseas may submit the paper form to the Italian diplomatic or consular representation in their country of residence or to any Revenue Agency office. The data will mainly be processed electronically and with logical systems that are adequate to the achievement of the objectives, which will also be pursued by checking: • the other data in the possession of the Ministry of the Economy and Finance and the Revenue Agency, also if provided, as required by law, by other persons · the data in the possession of other bodies Data When this data is made available to them and falls under their direct control, the Ministry of the Economy and Finance and the Revenue Agency become "the data controllers for the processing of the personal data". They controllers keep a list of the controllers, which is available upon request. "Data controllers" may make use of the services of others designated "responsible". Persons responsible for In particular, the Revenue Agency makes use of the services of the company So.ge.i. S.p.a. as the external data processing entity responsible for data processing, in its capacity as technological partner to which the management of the information system of the Tax Register is entrusted. Taxpayer's rights The person (taxpayer) concerned, in terms of article 7 of Legislative Decree No. 196/2003, may view his personal data at the premises of the data controller or the person responsible for data processing in order to verify the use to which it is being put or if necessary, to correct or update it within the limits provided for by law, or to cancel it or oppose its processing, where it is being processed illegally. Consent

The Ministry of the Economy and Finance and the Revenue Agency, in their capacity as public entities, do not need to acquire the consent of the persons concerned in order to process their personal data.
